In my most recent research, I looking at tests of the number of violations of revealed preference conditions and setting forth some of those conditions for indirect utility maximization. I have also been comparing monetary aggregates composed of different assets and constructed using different indexes. The monetary aggregates are chosen to be consistent with economic theory and the time-series characteristics of these aggregates are examined. Further, I have recently extended the concept of economic monetary aggregates to the idea of optimal or common currency areas and tested the existence of common currency areas in various places around the world.
