"I [was] so blown away by [Mr. Bergeron] knowing so much information about everything... We talked about events

that were driving changes in stock prices and what you would choose to invest in [he invited students to participate in the discussion by asking if you would choose to invest in] Tesla or GMC based on knowledge of hybrid cars [then if your investment decision would change if you had the knowledge that] gmc [is planning] to move fully electric soon. There was also some discussion about the stock market. In general, students asked questions, such as, "what should you do to be prepared to work on wall street".
