Information of interest to accredited programs

Degree-Granting Authority

The University of South Alabama was founded in 1963 and has degree-granting authority in accordance with Alabama law as a state institution of higher learning (16-55-1 of the Code of Alabama). Specifically, the code (16-55-4) states that the "trustees may prescribe courses of instruction, rates of tuition and fees, confer such academic and honorary degrees as are usually conferred by institutions of like character; and they may do whatever else they may consider in the best interest of the institution."

State Authorizations for Out-of-State Students

The University of South Alabama offers degree programs and courses to out-of-state students. The Office of Institutional Effectiveness (OIE) maintains and manages appropriate state authorizations for these programs and courses through its membership and compliance with requirements as outlined in the policy of the National Council for State Authorizations Reciprocity Agreements (NC-SARA). OIE also is the primary contact with the State of Alabama's state portal entity, the Alabama Commission on Higher Education.

Maintaining appropriate state authorizations is a multi-pronged approach:

First, The University is a member of the National Council for State Authorization Reciprocity Agreements (NC-SARA). Membership in NC-SARA allows the University to offer distance education in all other NC-SARA member states under the guidelines established in the NC-SARA Policy Manual version 21.1. The University is currently compliant with all reporting and policy expectations required by NC-SARA. One of the ways the University ensures compliance is by educating the campus community through its State Authorizations website and regular, semesterly communication with deans, chairs, and program coordinators of academic programs about NC-SARA and its requirements.

Second, where programs are also governed by a state licensing board (e.g., Master of Science in Nursing), there may be additional requirements that the University must meet to ensure appropriate state authorization. In these instances, the Office of Institutional Effectiveness works closely with programs leading to state licensure to make sure that they are compliant with expectations regarding professional licensure disclosure requirements. NC-SARA requires programs to provide disclosures about state licensure to prospective, admitted, and current students. Each of our programs provide program disclosures available via a dynamic search tool on the State Authorizations website. In addition to disclosures students receive from program faculty during the admissions and enrollment process, students can also visit the state authorizations web page, select their program, and view state-by-state disclosures, such as in this example from nursing.

As part of this process, programs determine whether the program meets a particular state's curricular and program requirements, if any. To date, the institution has not been required to report changes in program offerings to these agencies.

Finally, the University proactively communicates with students to ensure that they are regularly updating their address and location.

Institutional accreditation

Any reference to the University of South Alabama's institution accreditation must refer to the full name of our accrediting body: Southern Association of Colleges and Schools Commission on Colleges (SACSCOC).

Further, any statement about the University of South Alabama's institutional accreditation must be stated as directed by SACSCOC policy:

The University of South Alabama is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) to award bachelor's, master's, educational specialist and doctoral degrees. Information about the University's accredited status is published using consistent language in the <u>University Bulletin</u> (page 10), the <u>Student Handbook</u> (page 16), and on the <u>Institutional Effectiveness</u> <u>website</u>. Other areas of the University publishing information about the University's accredited status use the same statement and/or link to accreditation information on the Institutional Effectiveness website. For example, USA's off-campus instructional site in Baldwin County provides a description of its accreditation and a link to the Institutional Effectiveness website.

Institutional assessment of academic programs

All academic programs at the University of South Alabama participate in annual academic program assessment. As part of this process, academic programs identify 3-5 student learning outcomes and identify methods for assessing those outcomes. By the third Thursday in October, programs must report the data and information collected from their assessments and include their plans for how they will use that data to improve student learning. Throughout the year, programs must follow-up to indicate whether and how they implemented their plans to improve student learning. The faculty at USA promote an environment in which hands-on research is widely available to undergraduate and graduate students. As problem-solvers and pioneers in developing new technologies and promoting bold ideas, USA researchers collaborate across disciplines to address global issues and uncover new fields of inquiry.
