Biographical Note

The Dauphin Island Property Owner's Association (DIPOA) was formed in 1954 as a nonprofit organization dedicated to developing Dauphin Island in order to promote tourism. Since then, the DIPOA has participated in several improvement projects including building a public golf course and tennis center called Isle Dauphine Country Club and providing water and sewer service to the island's residents. The DIPOA also participates in shoreline restoration, specifically in areas damaged by hurricanes or other disasters. All Dauphin Island residents are members of the DIPOA, and there are currently just over 3000 voting members.

Scope and Contents

The Dauphin Island Property Owner's Association Records contains agreements with tenants and property owners as well as bills of sale, insurance documents, correspondence, deeds, maps of the island and various subdivisions, notes, inter-office memos, and photographs. **NOTE:** The collection mostly contains records from Julius E. Marx Realtors with a few documents from other sources. Mr. Marx served on the DIPOA board of directors for many years, during which time he kept these records.

Arrangement

Divided into 4 series: 1) Residential properties, arranged alphabetically by street name (5.5 linear feet); 2) General block listings, arranged alphabetically/numerically by block (.5 linear feet); 3) Commercial properties, arranged alphabetically by business name (.5 linear feet); and 4) Subdivision information including maps, arranged alphabetically by area name (.5 linear feet).
