#### **Biographical Note:**

The Mobile Female Benevolent Society was founded Mobile, Alabama, in 1829, as a nondenominational organization to aid indigent widows through the donation of food, clothing, and medical supplies. In 1835 the society built and maintained several houses at Dearborn and Warren streets, houses that were collectively known as "Widow's Row." Later the group purchased the Gazzam Home at the corner of Government and Ann streets, which remains the site of a new facility known as Murray House, which is operated by the Episcopal Diocese of the Central Gulf Coast under the auspices of the Mobile Female Benevolent Society.

#### Scope and Content:

Contains the society's constitutions (1831, 1937, 1951), articles of incorporation (1841), resident lists and personal information book (1873-1960), membership rolls (1939-1940), minutes (1860-1864, 1886-1892, 1897-1898, 1953-1954, 1982-1983, 1988-1989), correspondence (1869, 1901-1908, 1930-1969, 1989-1991), monthly account statements and budget requests (1945-1948), account statement books (1869-1897, 1938-1942), newsclippings (1952-1953, 1960), tax returns (1922, 1938, 1939, 1941-1943), treasurer's reports (1938), as well as photographs, memorabilia, and resident and personnel policies and real estate deeds for the society and for residents.
