Biographical Note:

M. L. Stabler (1843-1925) was born in Monroe County, Alabama, near Finchburg in 1843. He died at Lower Peach Tree, Alabama in 1925. He was the Son of Malachi Stabler and Theresa Jane Haynes Stabler and brother of Ellen Jane Stabler, Jane Ann Stabler, Catherine A. Stabler, Samuel J. Stabler, and Coralie Elizabeth Stabler.

He married his first wife, Lucy Ann Portis (1844-1886) in 1868, and then Margaret Elizabeth Carstarphen (b.1850) in 1899. He was father of Samuel Portis Stabler, Julia Mary Stabler, Martha Irene Stabler, Benjamin David Stabler, Malachi Lamar Stabler Jr., Lucy Adele Stabler, and Janie Hope Stabler

Malachi Lamar Stabler served the Confederate Military in Holtzclaus' Brigade, Maurice's Division as a private in Company G of the 21st Alabama Regiment during the Civil War. He was captured at Fort Gaines on August 8, 1864 and sent first as a POW to New Orleans and then to Ship Island on Oct. 25, 1864 where he was later exchanged on January 4, 1865. After a 30 day furlough he rejoined his unit. He was surrendered at Citronelle, Alabama, by Lt. General Richard Taylor on May 4, 1865, and paroled at Meridian, Mississippi, on May 13, 1865.

Malachi Lamar Stabler ran a successful mercantile business in the South, known as Stabler & Sons. The business was located in Lower Peach Tree, Alabama, from before the Civil War and into the 20th century.
